## MIRROR WARRANTY

FGD Glass Solutions [FGD] warrants all mirror products for a total of 5 years from original purchase date to the original purchaser.

FGD Glass Solutions' float glass conforms to ASTM C 1036-06 standard specification for flat glass. Inherent in the float glass process are some small gaseous inclusions and minor abrasions. Occasional small "bubbles" and hairlines are, therefore, perfectly normal, and acceptable under these standards and should be virtually unnoticeable from a normal viewing distance of 6'-0".

If the mirror contains defects in the silver, FGD Glass Solutions must be notified in writing at the address stated on the original invoice, at which point, FGD Glass Solutions reserves the right to inspect the mirror at the site and under the conditions where the defect was first detected.

Liability under this warranty is limited, at FGD Glass Solutions' discretion, to either:

- FGD Glass Solutions replacing the defective product without charge, F.O.B. On-Site System's plant.
- FGD Glass Solutions refunding 100% of the original selling price. Labor costs are not covered by this warranty.

FGD Glass Solutions' liability shall be limited solely to its responsibilities under this warranty. In no event shall FGD Glass Solutions be liable to any person or entity for indirect, special incidental or consequential damages or charges for any reason.

Warranty does not apply to replacement mirror beyond the warranty period applicable to the original mirror.

**This warranty is void under any of the following conditions:**

- Mirror is broken or cracked
- Mirror silver has been damaged
- Mirror is used or installed in an application other than indoors
- Mirror is installed in high-humidity environments
- Mirror has been subjected to standing water
- Mirror has been subjected to corrosive chemicals, grinding, lubricants, cleaning fluids, solvents, sealants, adhesives, chemical fumes, etc.
- A non-FGD Glass Solutions film has been attached to the mirror
- Mirror was installed in non-accordance to FGD Glass Solutions specifications

EXCEPT FOR THE EXPRESS WARRANTY DESCRIBED ABOVE, FGD GLASS SOLUTIONS NEITHER EXPRESSES NOR IMPLIES ANY OTHER WARRANTIES OF ANY KIND AND NO WARRANTY SHALL BE IMPLIED BY OPERATION OR LAW OR OTHERWISE.

No variation or change from this warranty will be binding upon FGD Glass Solutions unless made in writing specifically referring to this warranty and signed by an officer of Factory Glass Direct, LLC.
